

SUMMARY REPORT

Reporting Requirements for Animal Abuse

The following table highlights the states with laws and regulations requiring, allowing, or encouraging veterinarians and veterinary technicians to report animal abuse and cruelty, as well as states that provide civil immunity for good faith reporting of animal abuse. The AVMA recognizes that veterinarians may observe cases of suspected animal abuse or neglect as defined by federal or state laws, or local ordinances. The AVMA encourages states to include immunity from liability in any state legislation that could result in civil, criminal, or state licensing action against any veterinarian who reports, in good faith, a suspected case of animal abuse or neglect to the proper authorities.
